**AN ORDINANCE AMENDING ORDINANCE NO. 1171, SERIES 2003
RELATING TO THE NAMING OF CITY STREETS, BUILDINGS,
PARKS AND OTHER FACILITIES**

WHEREAS, the City Council of Jeffersontown, Kentucky adopted Ordinance No. 1171, Series 2003 to honor persons by naming facilities based upon a lifetime of contribution to the City and its residents, and

WHEREAS, the City Council desires to amend the aforesaid Ordinance to better accomplish that purpose.

**NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE CITY
COUNCIL OF JEFFERSONTOWN, KENTUCKY, AS FOLLOWS:**

Section I of Ordinance No. 1171, Series 2003 is amended to read as follows:

SECTION I: No City owned property, facility, park or street will be named for an individual unless the individual has been deceased for at least ~~five (5)~~ *two (2)* years.

All other provisions of Ordinance No. 1171, Series 2003 remain unchanged and in full force and effect.

RE: AMENDMENT TO ORDINANCE NO. 1171, SERIES 2003

It has been brought to my attention that Ordinance No. 1171, Series 2003, doesn't allow the naming of City owned property, facility, park or street after an individual prior to five (5) years of the deceased. Therefore, the Ordinance allowing us to name the Skyview Park Football Complex after John Franconia needs to be adjusted from five (5) years to two (2) years if we wish to accommodate the wishes of the Council and the needs of the City.

We all agree that the naming of the Football Complex after John Franconia is well deserved in recognizing an individual who devoted much of his life and resources to the encouragement of our youth sports and the betterment our community.

I will be asking for a First Reading of Ordinance No. 1298, Series 2013, at our Tuesday, October 15th Council Meeting in order to address and correct this issue.
