**ORDINANCE NO. 1309, SERIES 2014**

**AN ORDINANCE RELATING TO THE ABATEMENT OF NUISANCES  
AND AMENDING ORDINANCE NO. 1242, SERIES 2008 AND  
ORDINANCE NO. 1291, SERIES 2013 TO ADD ADDITIONAL ACTS  
AS UNLAWFUL AND ADDITIONAL REMEDIES.**

**WHEREAS,** The City of Jeffersontown, Kentucky has adopted Ordinance No. 1242, Series 2008, relating to the adoption of a Property Maintenance Code, containing therein at Sections 105, 201-208, 706 and 707 acts, actions, behaviors, or conditions which constitute nuisance violations; and,

**WHEREAS,** The City of Jeffersontown has adopted Ordinance No. 1291, Series 2013, adding additional provisions to the aforesaid Code; and,

**WHEREAS,** The City of Jeffersontown, Kentucky, desires to amend the Property Maintenance Code to add additional acts, actions, behaviors, or conditions which constitute nuisance violations, and to add additional remedies designed to enhance the ability to remedy and/or abate such nuisances.

**NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE CITY COUNCIL OF  
JEFFERSONTOWN, KENTUCKY, AS FOLLOWS:**

**Section I.** Section 711.1 is hereby amended to add the following:

Any violation of Section 95.05 of the Jeffersontown Code of Ordinances shall also constitute an unlawful act under this code.

**Section II.** Section 712 is hereby amended to add the following Section 712.7:

In addition to the penalties set forth above, the Code Enforcement Board may suspend and/or revoke any license issued by the City of Jeffersontown, Kentucky, to the person charged for a violation of Section 711.1, including, but not limited to, a license to do business or to traffic in alcoholic beverages. If, pursuant to a hearing, the Code Enforcement Board finds that there is an imminent and substantial threat to public safety, the Board may enter emergency orders temporarily suspending the license(s) issued By the City of Jeffersontown, Kentucky to the person so charged until a final adjudication of the matter.

**Section III.** This Ordinance shall take effect immediately upon passage and publication.


