ORDINANCE NO. 1419, SERIES 2021

AMENDMENT OF ORDINANCE NO. 1225, SERIES 2007, AMENDING  
ORDINANCE NO. 849, SERIES 1983, AS AMENDED BY ORDINANCE  
NO. 1040, SERIES 1992

BE IT ORDAINED BY THE CITY OF JEFFERSONTOWN, KENTUCKY, AS  
FOLLOWS:

SECTION I. Ordinance No. 849, Series 1983, as amended by Ordinance No.  
1040, Series 1992, as amended by Ordinance 1225, series 2007,  
is hereby amended as follows:

SECTION VI. Each person, firm or corporation installing, altering or adding  
to any installation for which a permit or certificate is required  
by this Ordinance shall pay the following fees to the City by  
paying them to the Electrical Inspector as agent for the City:

A. Residential Services

1. For each initial or rough inspection: Fifty Dollars (\$50.00)
2. For each re-inspection or final inspection: Fifty Dollars (\$50.00)
3. For each branch circuit: Three Dollars (\$3.00)
4. For each temporary on main: Fifty Dollars (\$50.00)
5. Minimal Permit Fee: Seventy-Five Dollars (\$75.00)
6. Temporary Pole Fee: Seventy-Five Dollars (\$75.00)
7. New Residential Home: Two Hundred Dollars (\$200.00)
8. Sub Panels (each) Thirty Dollars (\$30.00)

B. Commercial Buildings Services

1. Minimal Permit Fee: Seventy-Five Dollars (\$75.00)
2. Per Inspection: Fifty Dollars (\$50.00)
3. Per Circuit: Three Dollars (\$3.00)
